Flat rate shipping is commonly used by stores, and free standard delivery is usually available once you reach the minimum purchase requirement. However, not having to pay shipping fees at all is a great way to cut down on shopping expenses. This is why we created the *Dealhack Free Shipping Guide* to provide you with a list of stores that always offer free shipping no matter how much money you spend.

This list contains over 50 stores that are grouped into two main categories for your convenience. Free home shipping is the most convenient option because you only have to wait for your order to be delivered straight to your door. Free pickup can either be in-store and curbside, which are the next best options after home shipping since you only have to travel a few miles to your local retail or grocery store.

Free Home Shipping (No Minimum Purchase)



A4C: A4C offers free standard shipping on all electronic products for a limited time only. Available for all orders within the continental United States. Delivery takes 2-7 business days ([source](#)).

AbeBooks: Free standard shipping to addresses within the United States is available for select reading materials and collectibles from AbeBooks. Complimentary shipping options are also available for orders to Australia, United Kingdom, Canada, and Worldwide addresses ([source](#)).

Amoeba Music: Amoeba Music is offering free shipping via USPS Media Mail (3-14 business days) for all movie and music formats. Items that have been scanned by USPS are no longer eligible for refund or replacement ([source](#)).

Apple: The Apple Store offers free next-day shipping or free 2-day shipping for iPhones, MacBooks, iPads, Apple TVs, and Apple Watches that are in stock. For orders outside the continental United States, the average delivery time is 2-5 business days. Free shipping is not available for customized or engraved products ([source](#)).

Apples of Gold: Free standard shipping via UPS Ground delivery is offered by Apples for Gold. Available for all jewelry orders to addresses in the United States ([source](#)).

AT&T: Free shipping (2-3 business days) is available for all products from AT&T that are purchased from their online store. Free returns and exchanges are also available for unopened packages that were purchased online, by phone, or from any AT&T corporate-owned retail store ([source](#)).

Bed Bath & Beyond: Free curbside pickup is offered by Bed Bath & Beyond for select online orders. Bring one valid photo ID and your pickup confirmation email to your selected store location not more than 3 days after your order has arrived ([source](#)).

Better World Books: Better World Books is offering free standard shipping to all online orders. Estimated delivery time from U.S. facilities is 5-9 business days ([source](#)).

Billabong: Free shipping for all clothing and gear orders is available to members of the Billabong Crew Loyalty Program. No minimum purchase is required ([source](#)).

Bluemercury: Members of the BlueRewards program receive free ground shipping and returns on Bluemercury bath & beauty products. Available for deliveries to the 48 contiguous states only ([source](#)).

Blue Nile: Blue Nile is offering free shipping via FedEx to all jewelry purchased from its online store. Delivery options are ground shipping (1-7 days) for orders under \$500, 2-day shipping for orders between \$500-\$1000, and Priority Night Shipping for orders over \$1000 ([source](#)).

Bonobos: Bonobos is a fashion brand for men that is offering standard ground shipping for all orders in the continental U.S. via FedEx or USPS. Standard orders generally arrive within 7-10 days after purchase ([source](#)).

Buffy: All pillows, comforters, and bedding purchased from Buffy are eligible for free domestic shipping to the United States, including Alaska and Hawaii. Estimated delivery time depends if the order is shipped to a street address or a P.O. box ([source](#)).

BuyDig: Free 2-day shipping is available on electronics brands at BuyDig when you use the code [BDEXPRESS](#). For select TVs, mirrorless cameras, and Smart Home products, use the code [BD1DAY](#) to get free overnight shipping ([source](#)).

CB2: Thousands of furniture and home decor items for sale at CB2 are eligible for free standard shipping ([source](#)).

Crate & Barrel: Crate & Barrel is offering free shipping with no minimum purchase required for select furniture, kitchenware, and home decor. Items that are available for this option are marked with a red note in their product page ([source](#)).

Dell: Free standard shipping is available for all orders from the Dell online store. Members of Dell Rewards can upgrade to expedited shipping for free. Products for sale that have the Smart Selection icon on their webpage are ready to ship the following business day ([source](#)).

Emily Express: All regular labels purchased from Emily Express are qualified for free first class mail shipping to addresses within the continental United States. Estimated delivery time is 6-8 business days. For custom orders, another 1-2 business days must be allowed for processing ([source](#)).

Estee Lauder: Estee Lauder offers free standard shipping (4-10 business days) and returns for skincare products, makeup, and fragrances purchased online. Deliveries to Hawaii, Alaska, and U.S. territories take 14-21 business days ([source](#)).

Focus Camera: Free same-day shipping is offered by Focus Camera for orders placed before 4PM EST. For other products, 2-day shipping is available to addresses within the continental United States ([source](#)).

Fossil: Free standard shipping is available for all Fossil accessories. Estimated delivery time is 5-7 business days for addresses in the continental United States and territories except rural routes and P.O. boxes. Custom watches may take up to 2 extra business days for processing ([source](#)).

Free People: Free People offers complimentary standard shipping fees and returns for all deliveries to addresses within the United States. Available for a limited time only ([source](#)).

Hampden Clothing: Free ground shipping is offered by Hampden Clothing for all orders. Most items also come with a free return label if they qualify with the store's return policy. Available in the U.S. only ([source](#)).

HP: Chromebooks, ink and toner supplies, and other qualifying products ordered from the HP Store are eligible for free standard shipping (5-7 business days). Next-business-day shipping and 2-day shipping options are available for deliveries to select zip codes within the United States ([source](#)).

Hush Puppies: Free standard shipping via FedEx is offered by Hush Puppies for all orders within the continental United States. Estimated delivery time is 2-6 business after the order has been processed ([source](#)).

JanSport: JanSport offers free standard shipping (4-6 business days) and returns for online orders that will be delivered within the continental United States. For select items, two must be added to the cart in order to qualify for free shipping ([source](#)).

J. Crew: Members of J. Crew Rewards are eligible for free standard shipping (5-8 business days) on select orders to all 50 states, AFO/FPO addresses, Puerto Rico, and U.S. territories. Restrictions apply ([source](#)).

Journeys and Journeys Kidz: Free ground shipping is offered by Journeys and Journeys Kidz for domestic orders only. Processing time is 1-2 business days and delivery time is 3-5 business days ([source](#)).

Kate Spade: Kate Spade offers free standard shipping (3-5 business days) and priority shipping to all 50 states, including U.S. territories and AFO/PFO addresses. All orders will be delivered by USPS and additional handling fees will be added for select items ([source](#)).

Keds: Keds is offering free standard shipping and returns for all footwear orders within the continental United States. Estimated delivery time is 2-6 business days ([source](#)).

Lily Pulitzer: Free ground shipping and returns is offered by Lily Pulitzer for deliveries to all 50 states. Deliveries to AFO/FPO addresses and U.S. territorial islands will be delivered via Smartpost. Additional transit time might occur for orders shipped to Alaska and Hawaii ([source](#)).

Mabel's Labels: All regular-priced products purchased online at Mabel's Labels qualify for free standard shipping to home addresses within the United States. Standard delivery takes 4-11 business days after 1-2 days of processing the order ([source](#)).

MAC Cosmetics: MAC Cosmetics is offering free standard shipping (2-5 business days) for all makeup, skincare products, kits, beauty tools, and fragrances. Deliveries to U.S. territories, P.O. boxes, and DPO/APO/FPO take 6-21 business days ([source](#)).

Macy's: Apply for a Macy's Credit Card to qualify for free standard shipping for all orders within the continental United States. For orders that will be shipped to multiple addresses, free delivery only applies to the first address ([source](#)).

Madewell: Sign up to the Madewell Insider Program to receive free economy shipping (8-10 days) and standard shipping (5-8 days) for all eligible orders. Free expedited shipping (2-3 days) is available for Madewell Star and Madewell Icon members ([source](#)).

Manitobah Mukluks: Free standard shipping is offered by Manitobah Mukluks for all orders to select home addresses in the United States. Orders take 3-5 business days to be delivered after a processing period of 1-2 business days ([source](#)).

Maurices: Apply for a Maurices Credit Card to qualify for free standard ground shipping on all orders, with no minimum purchase required. The estimated shipping time is 3-8 business days, and this offer is only valid for deliveries within the continental United States ([source](#)).

Microsoft: Free expedited shipping (2-3 business days) is offered by the Microsoft Store to select orders within the continental U.S. and to Puerto Rico. Custom products may take additional time for processing and delivery ([source](#)).

Molton Brown: Molton Brown offers free shipping (3-7 business days) to all orders within the United States except Alaska, Hawaii, and U.S. territories. Available for all bath & body products purchased online ([source](#)).

[Nordstrom](#): Nordstrom is accepting orders from all 50 states, including Puerto Rico. Free shipping and returns is available for all orders, and delivery time is estimated at 3-6 business days ([source](#)).

[Neiman Marcus](#): Free standard shipping (3-5 business days) is available for most online orders at Neiman Marcus. Orders and deliveries are only processed on weekdays ([source](#)).

OfficeFurniture2Go: OfficeFurniture2Go is offering free shipping within the continental United States. Delivery takes 1-2 weeks depending on the size of the shipment. Available for a limited time only ([source](#)).

Palm Beach Perfumes: All fragrances and skincare products at Palm Beach Perfumes are qualified for free shipping (2-8 days). Standard ground shipping is free for all orders in the U.S., Guam, and Puerto Rico ([source](#)).

[Panasonic](#): Free standard ground shipping is available for most items ordered at the Panasonic online store. Not available for deliveries to Alaska and Hawaii ([source](#)).

Reformation: The Reformation is a clothing brand for women that offers free standard shipping and returns to the continental United States (5-10 business days) as well as Alaska and Hawaii (2-4 weeks). Deliveries only occur on weekdays ([source](#)).

[Ray-Ban](#): Ray-Ban offers free standard shipping and free returns to all 50 states, with additional transit time for Alaska and Hawaii. Standard and prescription frames are delivered within 5 business days while Remix custom frames take 6-7 business days ([source](#)).

Rothy's: All bags, footwear, and accessories that are purchased online at Rothys are eligible for free ground shipping (5-10 business days). Orders are shipped on the same day if they are placed by 9:00AM PST ([source](#)).

[Saks Fifth Avenue](#): Saks Fifth Avenue is offering free standard shipping (3-8 business days) on all orders for a limited time. Use the code [FREESHIP](#) during checkout ([source](#)).

Sam Adelman: Free standard ground shipping is offered by Sam Adelman for all shoe and clothing orders within the continental United States. The estimated delivery time is between 10-14 business days after the order has been processed ([source](#)).

Samsung: Samsung offers free standard ground shipping (1-5 business days) to all orders except TV models over 65" and home appliances. Available for delivery to all 50 states ([source](#)).

Shopbop: Free domestic ground shipping (1-3 business days) is available for Shopbop clothing and accessories that will be delivered to any address in the United States. For Amazon Prime users, free 2-day shipping is available except in U.S. territories ([source](#)).

Sixty Auto: Sixty Auto offers free shipping for all orders within the continental United States. Items shipped to Alaska and Hawaii will be charged a delivery fee if the total order exceeds \$50 ([source](#)).

SoftMoc: All regular-priced products ordered online at SoftMoc are eligible for free standard shipping to select U.S. home addresses. Delivery is estimated to take 1-4 business days after 1-2 days of processing ([source](#)).

Solstice Sunglasses: Solstice Sunglasses offers free ground shipping for all eyewear orders within the continental United States. Estimated delivery time is 5-6 business days ([source](#)).

Sunglass Hut: Free 2-day shipping is available from Sunglass Hut for all regular orders within the United States, while items shipped to U.S. territories will take an extra 1-2 business days. Personalized eyewear will take 3-5 business days to be delivered ([source](#)).

SuperJeweler: SuperJeweler offers free shipping on diamond rings, wedding bands, gemstone jewelry, and other items to all U.S. orders. DHL (2-5 days) and FedEx (2-3 days) will deliver orders that are \$1000 or below while USPS (1-3 days) and FedEx (overnight) will be handling orders above \$1000 ([source](#)).

Sweetwater: All musical instruments and audio equipment purchased from Sweetwater are qualified for free shipping to the continental U.S. and AFO/FPO addresses. Not available for oversized and special orders as well as deliveries to Alaska, Hawaii, and international destinations ([source](#)).

Target: Sign up for a Target REDcard to receive free standard shipping on all orders within the continental United States, Puerto Rico, and AFO/FPO addresses. REDcard members can also get an extra 5% off every purchase, a 30-day extension on returns and exchanges, and other exclusive benefits ([source](#)).

[The Children's Place](#): Free standard shipping or priority shipping is available for all orders from The Children's Place that will be delivered to any of the 48 contiguous states. For deliveries to Hawaii, Alaska, U.S. territories, and military addresses, the item must be sent to a P.O. box to qualify for free shipping ([source](#)).

Tiffany & Co.: Tiffany and Co. is offering free shipping to all orders delivered to continental U.S. addresses only. Shipping time is extended by 1-2 days for standard engraved jewelry and 3-4 days for monogrammed or hand-engraved jewelry ([source](#)).

Timberland: Timberland is a popular brand of footwear and outdoor apparel that offers free 3-day shipping and free standard ground (4-8 days) shipping to all orders delivered within the United States ([source](#)).

Twillory: Free domestic shipping is available for all Twillory clothing and accessories that will be sent to any address in the United States. Delivery time varies in the Midwest or East Coast (3-7 business days) or the West Coast (7-10 business days). All orders that were placed before 1:30PM EST will be shipped on the same day ([source](#)).

UGG: UGG offers free standard shipping and returns for regular-priced items delivered to any address in the continental U.S. For sale items, at least one regular-priced item must be included in the purchase to qualify for free shipping ([source](#)).

Vans: Any single purchase of Vans footwear is eligible for free 3-day shipping to any address within the 48 contiguous states. Exclusions apply ([source](#)).

Welry: Free standard shipping is available at Welry for all regular jewelry orders. Estimated delivery time is 2-4 business upon the receipt of your valid payment information ([source](#)).

Zappos: Free standard shipping for all orders is available at Zappos, while mobile app users and Zappos VIP members can upgrade to free expedited shipping. Items ordered online can be returned within 365 days or exchanged within 14 days after purchase ([source](#)).

Free Store Pickup (No Minimum Purchase)



There are brands that do not offer free shipping directly to a home or street address, but allow you to ship your order to your nearest store. These delivery options are usually called "Ship to Store", "In-Store Pickup", or "Buy Online, Pick Up In Store" (BOPIS). Curbside pickup is another option that is usually offered for free by grocery stores and retailers. Items that are in stock at your nearest store are sometimes available for pickup on the same day.

Academy: Academy Sports + Outdoors is offering free in-store pickup for eligible items purchased online. Orders that are placed before 8PM are usually available for pickup within 2 hours. Bring one valid photo ID and your order number not later than 7 business days after you are notified via email ([source](#)).

Ace Hardware: Free in-store pickup or curbside pickup is available at any Ace Hardware location. Same-day pickup is available for orders that are placed not later than 2 hours before closing hours. Bring your email confirmation and one valid photo ID to claim your order ([source](#)).

American Eagle: American Eagle offers free in-store pickup or curbside pickup for products purchased from their online store. Bring your confirmation email or one valid photo ID to claim your order. For items that qualify for "Free Pickup Today", they usually arrive within 2 hours after the order has been placed ([source](#)).

Champs Sports: Free store pickup is available for items purchased online at Champs Sports. Products that are in stock at your preferred store location can be picked up not later than 24 hours, while items that need to be shipped to the store may take 5-6 business days ([source](#)).

Dick's Sporting Goods: Dick's Sporting Goods is offering free in-store pickup or curbside pickup for orders placed online. Items that are in stock at your preferred store location are mostly available for pickup within one hour. Bring one valid

government-issued photo ID and your ready-for-pickup email to claim your items ([source](#)).

Focus Camera: Focus Camera is offering free store pickup for select items, and delivery time varies between same-day or 1-2 business days. Bring the "ready for pickup" confirmation email and one valid ID when claiming your order not more than 3 business days after it arrived at the store ([source](#)).

GAP: Free curbside or in-store pickup is offered by Gap at select store locations. Orders placed before 2PM are ready for pickup within 2 hours. Bring your confirmation email and one valid photo ID not later than 5 days after you have been notified that your order is ready at your selected store ([source](#)).

Guitar Center: The Guitar Center allows free same-day pickup for select products purchased online. For orders that have a "ship to store" option, the product can be picked up within 3-5 business days ([source](#)).

Home Depot: The Home Depot offers free same-day store pickup for items that are ordered online. For items that are not in stock at your local Home Depot, they can be purchased online and delivered to your nearest store for free pickup ([source](#)).

Kroger: Free in-store pickup is available at any Kroger grocery store when you schedule up to 7 days in advance. Using the app allows you to notify your local store if you are 15 minutes away so that the employees can prepare packing the items ([source](#)).

Lane Bryant: Free delivery is available for any product purchased online from Lane Bryant when you select the "Ship to Store" option. Delivery time is 4-6 business days and the item can be picked up for not more than 7 days after it has arrived at your local store ([source](#)).

Lowe's: Items that are purchased from the Lowe's online store can be picked up for free at your nearest store. If your item is not in stock, you can choose to have it delivered to your preferred store location and pick it up for free at a later date ([source](#)).

Menards: Most products sold online at Menards can be picked up in-store or shipped to your preferred store location for free. Bring one valid photo ID and a copy of the ready-for-pickup email confirmation to the Guest Order Pickup area ([source](#)).

Nordstrom: Free store pickup is available for items purchased online from Nordstrom. Choose between curbside pickup or have it delivered to your nearest store location to be picked up within 7 business days ([source](#)).

Nordstrom Rack: Nordstrom Rack offers free shipping for online orders that use the "ship to store" delivery option. Not available for items over 5lbs and for orders placed through the HauteLook or Nordstrom Rack apps ([source](#)).

O'Reilly Auto Parts: Free delivery is available for all online orders at O'Reilly Auto Parts when you choose in-store pickup. Bring one valid ID to the store where the product was shipped not later than 3 business days after you receive an email that your order has arrived ([source](#)).

Office Depot: Office Depot offers free curbside pickup for in-stock items. Orders placed 2 hours before closing time can usually be picked up on the same day, depending on the location of your preferred store. Most items ordered online and picked up in-store are qualified for a 5% discount ([source](#)).

Party City: Free in-store pickup or curbside delivery (9AM-8PM) is available for select online orders at Party City. Bring one valid photo ID and the pickup confirmation email at the Pickup Counter of your selected store location ([source](#)).

Pottery Barn: Pottery Barn and [Pottery Barn Kids](#) are both offering free in-store and curbside pickup services for select products purchased online. Items are usually ready for pickup within 2 hours after placing your order. Bring one valid ID and the order number to your selected store location not later than 5 days after receiving a confirmation email ([source](#)).

SoftMoc: Select items sold online at SoftMoc can be shipped to your nearest store for free when you choose the "in-store pickup" option. Orders can be picked up within 2-3 business days depending on the location ([source](#)).

Staples: Staples offers free in-store pickup for select products that are available in stock. Print your email order confirmation and bring a valid ID to your nearest store to claim your purchase ([source](#)).

Tillys: Free in-store pickup is available at all Tillys stores, while curbside pickup is offered at select locations. Same-day pickup applies to all orders except for those that are placed within 2 hours before store closing hours. Online exclusive items are not eligible for the free pickup option ([source](#)).

True Value: All products from True Value require no shipping fees when you choose the Ship-to-Store option. To claim your product, bring one valid photo ID and the order confirmation that will be sent to your email. Delivery takes 3-8 business days for orders in the continental United States and 15-30 days for orders to Hawaii and Alaska ([source](#)).

UNIQLO: UNIQLO stores in the United States are offering free in-store pickup for all online orders. Items that need to be shipped to your preferred store take 3-7 business days to arrive. Bring one valid photo ID and your pick-up email not later than 5 days after your order has arrived ([source](#)).

Urban Outfitters: Urban Outfitters offers free store pickup for items purchased online. Items that are in stock are ready within 24 hours while those that need to be shipped are ready for pickup in 4-6 business days. All orders placed for store pickup are held for 4 days before they are returned ([source](#)).

Verizon: Free pickup is available for select devices and accessories purchased online from Verizon. Choose between curbside or in-store pickup if your product is available in-stock at your local Verizon store ([source](#)).

Walgreens: Free standard shipping is available at Walgreens when you select "ship to store" delivery for select products. A confirmation email will arrive when your order is ready for pickup at your preferred store location ([source](#)).

Walmart: Walmart offers free same-day pickup for thousands of in-stock products. Download the free app and set a schedule for pickup at your local retail store ([source](#)).

West Elm: Free curbside pickup is available for most items from West Elm. Once you receive an email that your order is ready for pickup, bring your order number and a valid photo ID to your selected store location ([source](#)).

Williams-Sonoma: Williams-Sonoma is offering free curbside and store pickup services for select items ordered online. Claim your items not longer than 5 business days after they are ready for pickup by bringing one valid photo ID and your order number ([source](#)).
